9. AIMS & OBJECTS:

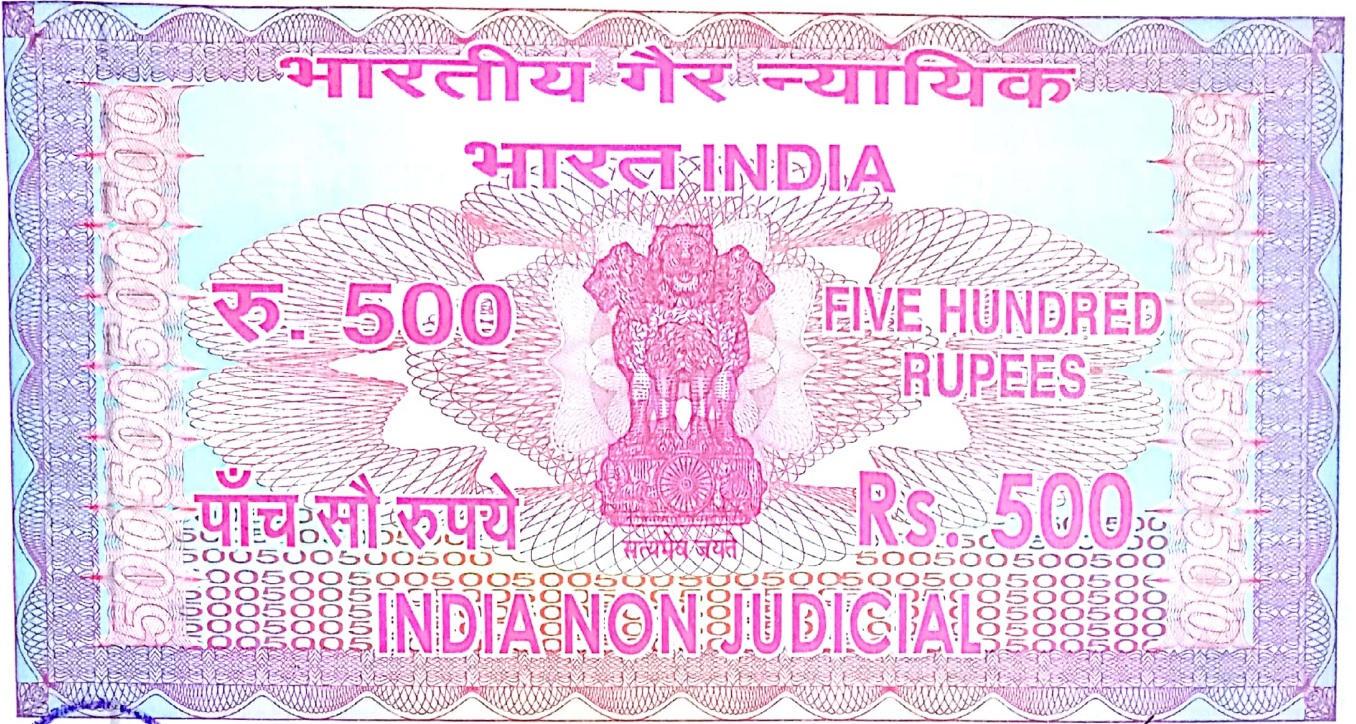

- ii) To ensure that the institution gets proper land, building, equipment, furniture and qualified staffs etc as per norms of the Board.
- iii) To ensure that the funds accruing from the school are spent for the benefit of the school and for its expansion.
- iv) To safeguard the autonomy of the Head of the institution / Principal and provide him / her total support except when he / she goes against the established and clear directives laid down by the management.
- v) To have control over the school managing committee and shall approve the budget / tuition fees and annual charges etc, for the school.
- vi) To have control over any capital expenditure.
- vii) To generate fund for the needs of the school whether it is recurring or non-recurring.
- viii) To ensure that the school has the basic essential facilities such as Lab equipment / games and sports and other co - curricular activities, Library books etc.
- ix) To have the powers to constitute / dissolve selection committee, promotion committee etc for staff.
- x) To have power to lay down conditions of services as per norms of C.B.S.E. Delhi state govt. and to approve promotion / appointment / termination of the employees as well as to grant special increments or reward to the staff.

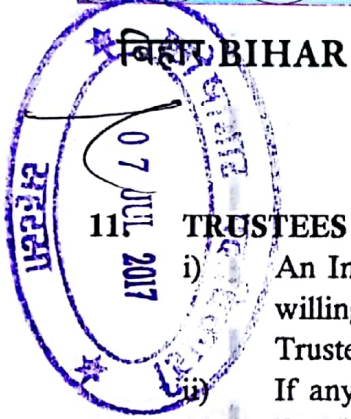
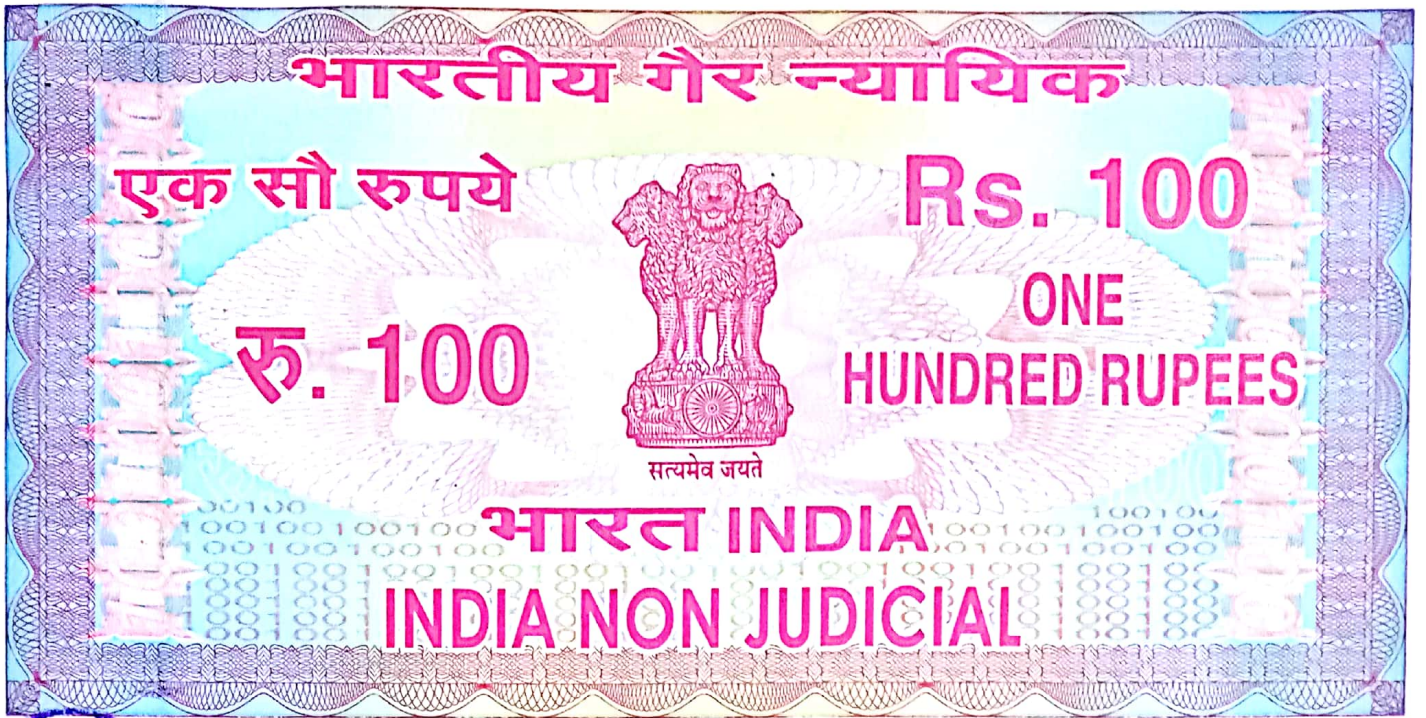

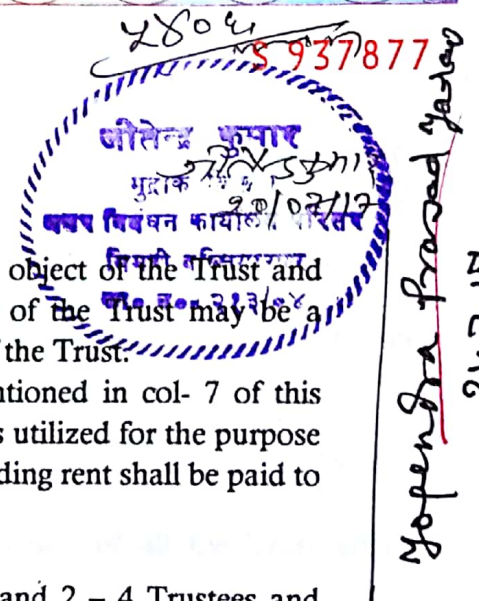

#### 11. TRUSTEES OF THE TRUST:

i) An Indian adult person who has faith in the aims and object of the Trust and willingly ready to follow up the rules and regulations of the Trust may be a Trustee of the Trust after the approval of the chairman of the Trust.

If any land / building (except the scheduled land mentioned in col- 7 of this Deed) of any Trustees, managing Trustee or Chairman is utilized for the purpose of Trust / Gayatri Shiksha Niketan , a proper land / building rent shall be paid to be person concerned.

#### 12. MANAGEMENT OF THE TRUST:

- i) The Trust shall have a chairman, a managing Trustee and 2 – 4 Trustees and Trust shall hereinafter be called jointly the "BOARD OF THE TRUSTEES".
- ii) The number of the Trustee in the Board may be added or reduced according to the will and discretion of the chairman of the Trust.
- iii) The Author Yogendra Prasad Yadav shall be the life time CHAIRMAN and on his demise his eldest son shall continue to be the chairman for generation in Male line.

Er. Satya Prakash Sudhanshu shall be the Managing Trustee and after his resignation or death the Managing Trustee will be chosen from amongst the Trustees according to the sweet will of the chairman.

v) All Trustees including Managing Trustees are bound to fulfill the object of the Trust and to obey the direction of the Chairman.

#### 13. POWER AND FUNCTION OF THE CHAIRMAN:

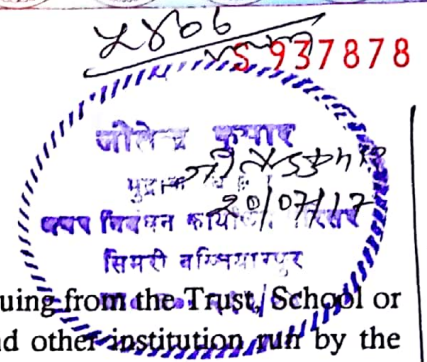

14. POWER AND FUNCTION OF THE MANAGING TRUSTEE:

- i) The Managing Trustee shall carry out instructions of the Chairman and decision of the Board of Trustees.
- ii) He / She will maintain clear and accurate account of all the Trust affairs properties.
- iii) The Managing Trustee shall represent the Trust at all Places concerned in any matter arising in any court of law, office or any where.

15. POWER AND FUNCTION OF THE TRUSTEE:

- i) The Board of Trustee shall frame their own rule and regulation within Indian Trust Act for Trust affairs according to which the Trust shall be managed.
- ii) The Board of Trustees shall carry out the objects of the Trust only with such funds as may be made available to them.
- iii) Any authorized Trustee may represent the Trust at all Places concerned in any matter arising in any court of law, office or any where.
- iv) Any Trustee may be removed from the Board of Trustees due to his / her acts or behavior against the objects of the Trust.

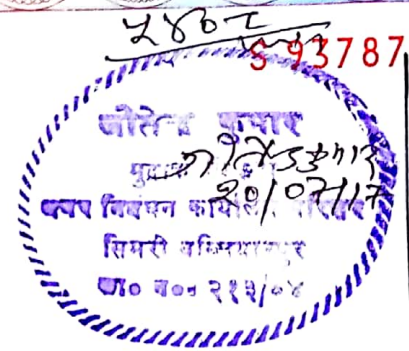
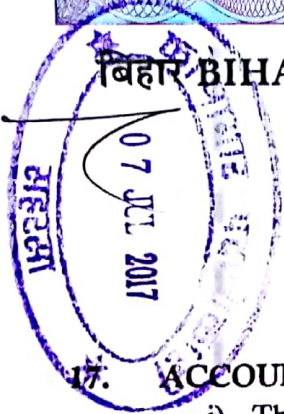


16. MEETING:

**17. ACCOUNTS OF THE TRUST:**

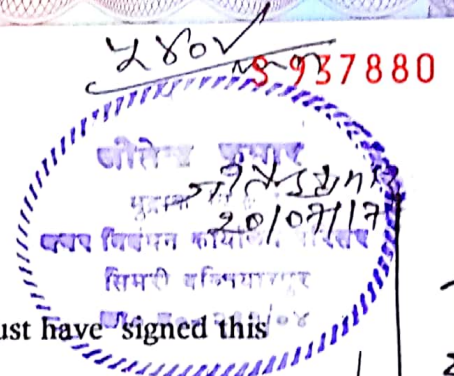
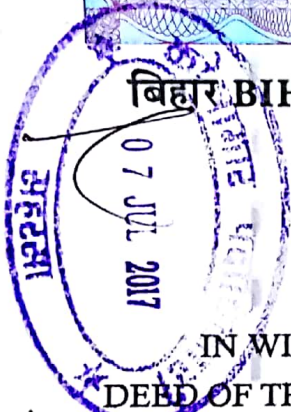
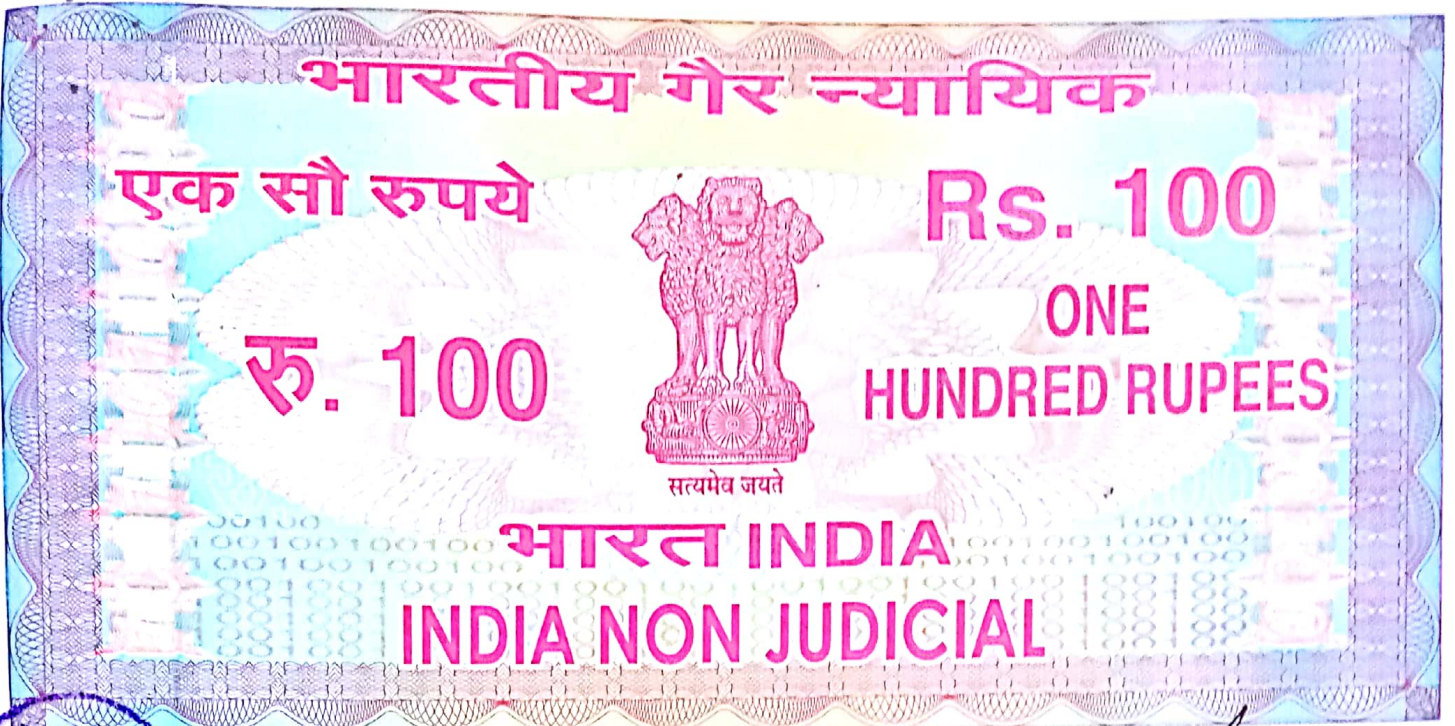
- i) Any act or things which is not mentioned here but executed by the Trust as and when required will be according to the Indian Trust Act 1882.
